

Accident Closes 281 North

High Add training rece Add ACCIDENT Plan

Highway 281 is closed about 4 miles south of Adamsville. Lampasas Radio heard earlier that traffic was being rerouted down FM 1690, but more recent reports indicate FM 1690 is blocked. The Adamsville VFD reports traffic backed up for miles. Please avoid the area.

Early this morning two 18 wheelers were traveling on 281 approximately 4 miles South of Adamsville near Patterson Creek. According to law enforcement at the scene, they hit a slick spot and crashed. One truck was hauling steel and one was a pneumatic tanker hauling what is believed to be calcium. Both vehicles were destroyed. One driver was unhurt and the other has been transported by ambulance.



District Court Notes

Lampasas Courthouse was the site of a 27th District Docket Call on January 10th. Presiding over ht Court was 27th District Judge John Gauntt.



There were 31 cases involving possession of a controlled substance PG1. 18 for less than a gram, 8 for 1-4 grams, 3 for 4-200 grams, and 2 for less than a gram of controlled substance in a drug free zone. There were 2 cases involving DWI 3rd or more. There were 2 cases for burglary of a building, one for theft of a firearm, and one for misappropriation of a fiduciary instrument \$2500-\$30,000. There was one case for forgery involving an elderly person. Crimes causing personal harm included 4 assault cases involving family/household members, and one assault with a deadly weapon case. Other cases include 2 cases of a prohibited substance in a correctional facility, two cases for tampering/fabricating evidence with intent to impair. There was one case of engaging in organized criminal activity where the defendant, Alyxander Wilson, was granted medical clemency.

There were 2 cases involving aggravated sexual assault of a child, one case of indecency with a child/sexual contact, one case involving a sex offenders duty to register, one case of sexual performance/child/employ/induce/authorize and one case of online solicitation of a minor/sexual conduct.

Of the 56 cases presented to the court, 12 were resolved. William Goudeau of Kempner on 2 counts of possession a controlled substance PG1 less than a gram, received 4 years TDCJ with credit for days served. Storm Hamilton on 2 counts of burglary of a building was sentenced to 3 years probation with the condition of attending ISF. On the charge of Aggravated Sexual assault of a child, Zachary Porter of Kempner received 7 years probation plus court costs. Melissa Oliver on the charge of misappropriation of fiduciary/financial property of the elderly received 10 years probation plus costs and restitution. Josh Maxcy of Kempner on the charge of tamper w/ evidence w/intent to impair received 3 years TDCJ with 395 days credit plus court costs. On the charge of possession of a controlled substance PG1 less than a gram, Mr. Maxcy received 12 months state jail with credit for 466 days plus costs. Jesse O'Neal, of Lampasas, on the charge of possession of a controlled substance PG1 less than a gram received 5 years probation w/SAFPF. On the charge of possession of a controlled substance PG1 4-200 grams, he received 7 years probation w/ (continued on back) SAFPF plus costs.
