## The Weather

#### The High yesterday $64^{\circ}$ The Morning Low $47^{\circ}$

**Today:** Cloudy, with a high near  $60^{\circ}$  with patchy drizzle and fog this morning. This afternoon winds will become light from the E-SE, there may be some clearing.

**Tonight:** Cloudy, with a low around  $56^{\circ}$  and calm wind. There is a 20% chance of patchy drizzle late in the night.

**Sunday**: Cloudy with a high near 71° and SE winds at 5-10 mph. There is a 30% chance of showers and storms in the afternoon.

Sunday overnight: An 80% chance of showers and storms, and a low of  $51^{\circ}$ . Winds will be SE shifting W at 5-10 mph gusting to 25 mph.

**The Lampasas County Commissioners' Court** will hold a regular meeting Monday at 9am in the Commissioners'

The Agenda includes the consent agenda, accounts payable/ payroll; a discussion of the county-wide Burn Ban; the approval of bonds for elected officials, discussion of leave for Covid-19 related absence for work; a resolution concerning the private railroad crossing at Lee Gap; lawn maintenance; a request bid for asphalt & emulsion; the Sheriff's Department request of approval of a lease agreement with Enterprise for fleet units; Child Welfare Board business, a racial profiling reports for 2020 from Constable Dennis James; and, of course the Jail Project 2017

The Lampasas City Council will meet Monday evening for a workshop, executive, special and regular session beginning at 5:30pm. The agenda for the workshop session includes; a presentation by Jason Jones of Jones-Heroy Consulting engineers regarding the pre-treatment study for the city's wastewater plant and recommendations. Discussion and updates on the City of Lampasas Public Safety Communications System Equipment, and discussion regarding possible amendments to the City of Lampasas Employee Personnel Policy.

Council will then go into executive session for an economic development issue, then return to a special session for discussion and possible action discussed in executive session.

Council will then begin the regular meeting which includes the consent agenda, the second reading of an ordinance regarding a request to rezone property at 907 E. 3<sup>rd</sup> St. form light industrial to two family residential, board & departmental reports, routine matters to include the city manager's operational report, and mayor's comments. New business includes discussion and consideration of the following; a contract services agreement between the City and County of Lampasas., use of Joint Use

Facilities Fund for a Central Texas Water Corporation Plant upgrade, nominating a candidate for the Board of Directors of the Central Texas Water Supply Corporation, and expenditure for bathrooms for the street & electric department building in the amount of \$35,750, acceptance of the 2019-2020 year-end financial report, and an ordinance concerning the May 1<sup>st</sup> general election.

## **Coronavirus Update**

Dr. Hay shared this morning that Lampasas County now has 142 active cases, an increase of 25 active cases since yesterday, and 1369 total cases, an increase of 61 total cases reported since yesterday. 8 residents of Lampasas County are in the hospital. The State of Texas saw 17,862 new confirmed cases yesterday, and 3,978 new probable cases. 13,344 Texans are hospitalized with Covid-19.

The DSHS website shows that as of yesterday at 5:28pm, Lampasas County has had 463 people vaccinated with one dose, and 55 residents have been vaccinated with the second dose. Also, according to the DSHS website, as of 5:28pm yesterday, Texas has been sent 2,567,350 total doses of the vaccine. Of the vaccines received, 1,600,794 doses have been administered. That is a total of 62% of the available vaccine. 1,372,480 Texas residents have received one dose, and 228,314 have been fully vaccinated.
