House Fire in Lampasas County

According to a press release from Sheriff Jess Ramos, "on March 15, at approximately 11:04am, Lampasas County Sheriff's office received a call of a structure fire at the 4800 block of County Road 3640 on the border of Lampasas and Corvell Counties. Lampasas County Sheriff's Deputies responded to the call and found a residence fully engulfed in flames. Kempner Volunteer Fire Dept. and the Lampasas Fire Dept. were notified and responded. The home owner, Ruby Miller, 84, was washing dishes when she discovered the fire in the living room area. She immediately attempted to battle the fire to extinguish it. Mrs. Miller's hair and shirt caught on fire in her attempts but she continued to fight the fire. The fire then grew to a dangerous level so she exited the house. Her son, Robert Miller, who lives approximately a quarter mile south of his mother's residence, had come home early from work when he observed that his mother's house was on fire. He immediately went to her rescue and found her sitting outside as she watched her house burning. Mrs. Miller sustained severe burns to her feet. She also received less severe burns on her face, neck, chest, arms and hands. Acadian EMS was summoned to the Miller residence where she was treated and transported by ambulance to Seton Hospital in Harker Heights. Due to the strong winds, the fire spread quickly jumping CR 3640 and racing across the pastures and hillsides. Several other fire departments were toned out to assist with the rapid spreading fire. Lometa VFD, Adamsville VFD, Gatesville Fire Dept., Evant VFD, Copperas Cove Fire Dept., the Texas Forestry Service and the

Texas State Fire Marshalls responded to assist. Lampasas County Commissioners Precincts 1 & 4 also responded with heavy machinery to assist with the creation of fire breaks. Hamilton Electric and Star Propane also responded to assist with the electric power and gas lines. Lampasas County and Coryell County Sheriff's Deputies assisted with traffic control and the evacuation of rural residences that were in the path of the spreading fire.

Lampasas County Sheriff Ramos responded to the scene then drove to Seton Hospital to check on the status of Mrs. Miller. The Sheriff found her to be responsive and Seton Hospital advised her medical condition was stable. Lampasas Fire Dept. Marshall JP Harris will assist with the cause of the fire investigation. All fire agencies cleared the fire scene at 5:33pm."

3 Oaks Fire in Evant

The Fire near Star/Evant has been named the 3 Oaks Fire by the Texas A & M Forestry service and at last update had burned 3500 acres and was 90% contained.

District Court Notes

Lampasas County Courthouse was the site of a 27th District Court Docket Call on March 11th. Presiding over the Court was 27th District Court Judge John Gauntt. Altogether 34 cases were brought to the court with 23 cases involving men, and 11 cases involving women.

Sheila Parker, of Lampasas failed to appear on the charge of possession of a controlled substance PG1/1-4 grams.

There were 9 cases involving possession of a controlled substance/PG1. There were 2 cases for less than a gram, 3 cases for 1-4 grams, one case for 4-200 grams, and one case for manufacture and delivery. There were 2 cases for possession of a controlled substance PG1/1-B/less than a gram. There was one case for possession of a controlled substance, PG 2 greater than 400 grams.

There was one case each for prohibited substance in a correctional facility, evading arrest, unauthorized use of a motor vehicle, bail jumping/failure to appear, debit card abuse and theft of property. There were 2 cases for forgery and 4 burglary cases. (cont'd)

The Burn Ban is in Effect!!

In cases causing personal harm there were 5 cases of assault of a family/household member. There was one case each for stalking, aggravated assault/public servant, unlawful display or promotion of intimate visual recording, continuous violence against the family, failure to comply as a sex offender and one case of indecency w/ child/exposure.

Of the 34 cases before the court 7 were resolved with Millennium Taylor seeing her charge of debit card abuse reduced to a class A misdemeanor and was sentenced to 2 years probation plus court costs & fines. Brandon Young, on the charge of assault on a family/ household member/previous convictions was sentenced to 10 years TDCJ, all probated plus court costs. On the second charge of assault of a family member/previous convictions, Brandon Young plead guilty, had his probation adjudicated and was sentenced to 2 years TDCJ w/ credit for time served. Angelica Leon plead guilty to possession of a controlled substance PG2 greater than 400 grams and was sentenced to a \$2000 fine plus court costs. On the charge of theft of property, Jayson Clough was sentenced to a \$500 fine plus court costs. Austin Miller, on the charge of unlawful disclosure or promotion of intimate visual recording was sentenced to a \$1000 fine plus court costs with 6 months to pay. Shannon Reid, on the charge of continuous violence against family saw her probation continued and must attend a SAFPF program.

All cases were rescheduled or set for jury trials.


Coach Evans makes 100 wins
