The Weather

District Courts

Lampasas County Courthouse was the site of a 27th District Court Docket Call on June 24th. Presiding over the Court was 27th District Court Judge John Gauntt. Altogether 41 cases were brought to the court with 32 cases involving men, and 9 cases involving women.

There was 1 defendant that failed to appear. Christopher Beamon failed to appear on 2 charges of theft from a person.

There were 19 cases involving possession of a controlled substance/PG1. There were 10 cases for less than a gram, and 8 cases for 1-4 grams. There was 1 case for possession of a controlled substance PG1 4-200 grams. There was one case for possession of a controlled substance PG 2 less than a gram. There were 4 DWI cases.

There were 4 cases of evading arrest, two cases each for burglary, theft from a person and engaging in organized criminal activity. There was 1 case each for taking wildlife resources with out consent, bail jumping/FTA, interference in child custody and unlawful possession of a firearm by a felon.

In crimes involving personal harm, there were 3 cases of assault on a family member.

Of the 41 cases, 11 were resolved with Andrew Dooley pleading guilty to possession of a controlled substance pg1 less than a gram and was sentenced to 9 months state jail w/ credit for 161 days. Rex Ann Call pled no contest to interference with child custody and received a sentence of 5 years probation plus court costs and fines. Jeffrey Fielding of Gatesville pled guilty to possession of a controlled substance PG1 less than a gram and was given 6 months in state jail w/226 days of credit. Savannah Lawson of

Lampasas was sentenced to 5 years probation w/SAFPF as a stipulation for possession of a controlled substance PG1 1-4 grams plus court costs and fines. Noah Joy pled true to engaging in organized criminal activity and possession of a controlled substance PG 2 less than a gram and received 90 days in county jail on each charge and continuing probation w/sanctions. Candice Pabst was sentenced to 4 years probation plus court costs on the charge of possession of a controlled substance PG1 less than a gram. Kevin Havins was found guilty of possession of a controlled substance PG1 1-4 grams and was sentenced to 4 years in TDCJ. Mr. Havins also pled guilty to DWI/felony repetition and unlawful possession of a firearm by a felon and was sentenced to 4 years TDCJ plus court costs on each of those charges as well. Sheila Parker pled guilty to possession of a controlled substance PG1 1-4 grams and was sentenced to 5 years TDCJ plus court costs w/credit for days served.

All other cases were rescheduled or set for jury trials.



Heat Related Illness

During extremely hot and humid weather, your body's ability to cool itself is challenged. When the body heats too rapidly to cool itself properly, or when too much fluid or salt is lost through dehydration or sweating, body temperature rises and you or someone you care about may experience a heat-related illness. It is important to know the symptoms of excessive heat exposure and the appropriate responses. The Centers for Disease Control and Prevention (CDC) provides a list of warning signs and symptoms of heat illness, and recommended first aid steps. Some of these symptoms and steps are listed below.

Heat cramps may be the first sign of heat-related illness, and may lead to heat exhaustion or stroke. Symptoms: Painful muscle cramps and spasms usually in legs and abdomen and Heavy sweating.

First Aid: Apply firm pressure on cramping muscles or gently massage to relieve spasm. Give sips of water unless the person complains of nausea, then stop giving water. Seek immediate medical attention if cramps last longer than 1 hour. Heat Exhaustion symptoms: Heavy sweating, Weakness or

Heat Exhaustion symptoms: Heavy sweating, Weakness or tiredness, cool, pale, clammy skin; fast, weak pulse, muscle cramps, dizziness, nausea or vomiting, headache, fainting, First Aid: Move person to a cooler environment, preferably a well air conditioned room. Loosen clothing. Apply cool, wet cloths or have person sit in a cool bath. Offer sips of water. Seek immediate medical attention if the person vomits, symptoms worsen or last

medical attention if the person vomits, symptoms worsen or last longer than 1 hour Heat Stroke Symptoms: Throbbing headache, confusion, nausea, dizziness, body temperature above 103°F, hot, red, dry or damp

skin, rapid and strong pulse, fainting, loss of onsciousness. First Aid: Call 911 or get the victim to a hospital immediately. Heat stroke is a severe medical emergency. Delay can be fatal. Move the victim to a cooler, preferably air-conditioned, environment. Reduce body temperature with cool cloths or bath. Use fan if heat index temperatures are below the high 90s. A fan can make you hotter at higher temperatures. Do NOT give fluids.

*Using a fan to blow air in someone's direction may actually make

them hotter if heat index temperatures are above the 90s. For more information on all of these heat related illnesses, see the Centers for Disease Control and Prevention (CDC) site.

Court Rules in Favor of Bullet Train

The company proposing a \$30-billion project to build a high-speed bullet train that will shorten the commute from Dallas to Houston by two and a half hours received a win on Monday, but it may come at a cost to landowners.

On Monday, the Texas State Supreme Court ruled in a 5-3 decision in favor of Texas Central's project that'll run through Central Texas and said the organization was entitled to private land of the planned trail connecting the two major cities on the basis of "eminent domain."

"Eminent domain" is a Fifth Amendment right from the Bill of Rights that says the government can seize privately-owned property, but as long as they pay for it.

In the High Speed Rail Alliance's article, Texas Central can pay fair-market rates to acquire the land needed to construct the 240-mile railway, which would turn a four-hour drive into a 90-minute train ride.

The commute from Dallas to Houston is one of the fastest growing super commute in the country. Part of that commute is a stretch of Interstate 45 was ranked the nation's most dangerous road in America.

Texas Central celebrated this Supreme Court decision, in a quote saying, "We are appreciative to the Texas Supreme Court for their time and consideration of this important issue as we continue work on this innovative high-speed passenger train rail."
