There was .21 inches of rain at the airport yesterday.

**Today:** Skies will be mostly sunny with a high temperature near 88°. Winds will be N-NE 5-10 mph.

**Tonight:** Partly cloudy skies and the low temperature will dip to near 69°. Winds will be E-NE at 5-10 mph then become light and variable. .

**Wednesday:** Mostly sunny, with a high temperature near 90°. Wind will become light from the E-NE.

## District Court Notes



Lampasas County Courthouse was the site of a 27<sup>th</sup> District Court Docket Call on July 30th. Presiding over the Court was 27<sup>th</sup> District Court Judge John Gauntt. Altogether 23 cases were brought to the court with 19 cases involving men, and 4 cases involving women. Four defendants failed to appear; Daniel Page of Copperas Cove on the charge of possession of a controlled substance PG1/less than a gram, Brady Finney of Killeen on a fraud charge, Yoannis Aguilera of Naples Florida for possession of a controlled substance PG1 less than a gram, and Brandi Frazier of Lampasas for possession of a controlled substance PG1 4-200 grams.

There were 8 cases involving possession of a controlled substance/PG1. There were 5 cases for less than a gram, 1 case for 1-4 grams, and 2 cases for 4-200 grams. There was 1 DWI case, and one case for possession of PG2 less than a gram.

There was 1 case each for; unauthorized use of a motor vehicle, fraud, credit/debit card abuse, burglary and 1 case for prohibited substance in a correctional facility. There were also 4 cases of engaging in organized criminal activity.

Cases involving personal harm included 1 case for indecency w/a child sexual contact, 1 case for assault on a family member, 1 case for aggravated assault w/a deadly weapon and one case for sexual assault of a child.

Of the 23 cases, 2 were settled with Jeffrey Meadors of Haynesville Louisiana receiving 31 days of county jail, credit for 31 days served, on the charge of possession of a controlled substance PG1 less than a gram. Brandon Howard of Lampasas received 5 years probation on the charge of sexual assault of a child.

All other cases were rescheduled or set for jury trials.

## Coronavirus Update

According to the DSHS, statewide, 3,781 new cases were reported on August 2<sup>nd</sup>, there were 577 probable cases and 4 fatalities. 6,853 Texans were hospitalized yesterday with the virus. Locally, on August 2nd, the DSHS reported Lampasas with 25 new cases, and there have been 125 confirmed in Lampasas County in the last 14 days.

## Texas Broadband

Texas Comptroller Glenn Hegar announced yesterday his agency will operate a newly created Broadband Development Office (BDO). The BDO will award grants, low-interest loans and other financial incentives to internet service providers who expand access to broadband service in underserved areas.

"Easy, secure internet access is increasingly important in our society, and it was essential during the pandemic. So, I am grateful that lawmakers made the expansion of broadband access across Texas a priority through the creation of the Broadband Development Office at my agency," Hegar said. Greg Conte has been selected to serve as BDO director.

"The COVID pandemic has highlighted the importance of reliable internet access. The linchpin to this office's success will be building meaningful, open relationships with state and local partners," Conte said. "I look forward to supporting the office's mission by fostering and maintaining those connections."

The office, will also do the following:

Create a broadband map indicating areas eligible for financial assistance; set an effective threshold speed for broadband service in those underserved areas at 25 megabits per second (Mbps) download and 3 Mbps upload; create and update a state broadband plan; engage in outreach to communities regarding the expansion and adoption of broadband service and the programs administered by the BDO; and serve as the state's subject matter expert for federal funding to help local governments

In December 2020, Connected Nation Texas, a broadband advocacy group, estimated that 316,717 Texas households were "unserved" by 25/3 Mbps broadband, about 89 percent of them in rural areas.

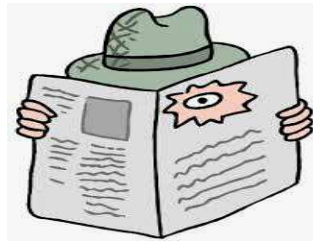
