

District Court Notes



Lampasas County Courthouse was the site of a 27th District Court Docket Call on August 6th. Presiding over the Court was 27th District Court Judge John Gauntt. Altogether 24cases were brought to the court with 19 cases involving men, and 5 cases involving women.

There were 11 cases involving possession of a controlled substance/PG1. There were 6 cases for less than a gram, 4 cases for 1-4 grams, and 1 case for 4-200 grams. There was also a case for manufacture/delivery controlled substance PG3/4 200-400 grams. There was one case for possession of marijuana 50-2000 lbs. There were 2 DWI cases.

There was 1 case each for; forgery, evading w/ serious bodily injury, and burglary of a habitation w/ intent to commit other felony. Cases involving personal harm included 2 cases for indecency w/a child sexual contact, 1 case for aggravated assault w/a deadly weapon and one case for sexual assault of a child under 14 continuously. There was one case for unlawful disclosure of intimate visual material, and one case for prostitution/payor soliciting a person under 18.

Of the 23 cases, 5 were settled with Ricky Williams of Temple pleading guilty to forgery, he was sentenced to 5 years TDCJ probated plus restitution and court costs. Amos Zavala of Abernathy, Texas saw his charge reduced from aggravated assault w/deadly weapon to assault causing bodily injury, he was sentenced to 2 days in the county jail w/credit for time served plus a fine and costs. Cody Cash, of Abilene plead guilty to possession/controlled substance/PG1 as a class a misdemeanor and was sentenced to 1 day in jail plus costs and fines. Deangelo Dunlap of Killeen plead guilty to possession of marijuana 50-2000 lbs and received a fine, costs, and 8 years of probation. Robert Hughes of Lampasas was found guilty of burglary of a habitation w/ intent to commit other felony and was sentenced to 10 years TDCJ w/ credit for days in county jail.

The remainder of the cases were reset or are waiting on jury trials.

There will be a vaccine clinic tomorrow, August 11th at Lampasas High School in the cafeteria. This is open to the public, free of charge, no appointment needed. The clinic will be from 9am to 4pm and they will offer the Pfizer 1st & 2nd shots for those 12 and older, and the Johnson & Johnson shot for those 18 and older.

Coronavirus Update

According to the DSHS, statewide, 2,151 new cases were reported on August 9th and there were 235 probable cases and 8 fatalities. 9,462 Texans are hospitalized with the virus. Locally, on August 9th, the DSHS reported Lampasas with 8 new cases, and there have been 145 confirmed in Lampasas County in the last 14 days. The state estimate held at 201 active cases.

Covid-19 and **Texas Hospitals**

According to a story in the Texas Tribune, Dozens of Texas hospitals have run out of intensive care unit beds as COVID-19 surges faster than any other time during the pandemic, propelled by the new delta variant.

The state is divided into 22 trauma service areas, and half of them reported 10 or fewer available ICU beds on Sunday. As more than 9,400 COVID-19 patients fill the state's ICUs, which are reserved for the patients who are the sickest or most injured, the trauma service area that includes Laredo reported no available ICU beds, while the area that includes Abilene reported having one.

At least 53 Texas hospitals have no available ICU capacity, according to numbers reported to the federal government during the week ending Aug. 5. In Austin, five hospitals were at or above 90% of their ICU capacity during the same period, (cont'd on back)



"This surge is by far the fastest and most aggressive that we've seen. Almost all of our hospitalizations are due to unvaccinated patients developing severe illness," Dr. Desmar Walkes, Austin-Travis County's health authority, told reporters last week. "ICU staff are seeing a younger population in our hospitals. Patients in the ICU are sicker and stay in the hospital longer than with prior surges, putting more strain on hospital resources.

During the week ending on August 5, 53 Texas hospitals reported that their ICU beds were filled to capacity
