## The Weather

**Today:** Mostly cloudy skies with a 70% chance of precipitation this morning. The high temperature will top out near 88°, and heat index values near 98°. Wind will be S at 5-15 mph gusting to 20 mph.

**Tonight:** Mostly cloudy and a low near 75°. Winds will be SE at 10-15 mph gusting to 20 mph. There is a 30% chance of showers and storms in the overnight.

## Governor Abbott Tests Positive for Covid

Office of the Governor Communications Director Mark Miner yesterday issued a statement after Governor Greg Abbott tested positive for COVID-19:

"Governor Greg Abbott on August 17th tested positive for the COVID-19 virus. The Governor has been testing daily, and today was the first positive test result. Governor Abbott is in constant communication with his staff, agency heads, and government officials to ensure that state government continues to operate smoothly and efficiently. The Governor will isolate in the Governor's Mansion and continue to test daily. Governor Abbott is receiving Regeneron's monoclonal antibody treatment.

"Governor Abbott is fully vaccinated against COVID-19, in good health, and currently experiencing no symptoms. Everyone that the Governor has been in close contact with today has been notified. Texas First Lady Cecilia Abbott tested negative."

## District Court Notes

Lampasas County Courthouse was the site of a 27<sup>th</sup> District Court Docket Call on August 13th. Presiding over the Court was 27<sup>th</sup> District Court Judge John Gauntt. Altogether 53 cases were brought to the court with 39 cases involving men, and 14 cases involving women.



There were 17 cases involving possession of a controlled substance/PG1. There were 11 cases for less than a gram, 3 cases for 1-4 grams, and 3 cases for 4-200 grams. There was also a case possession of a controlled substance/PG2 less than a gram. There were 6 DWI cases.

There was 1 case each for; criminal mischief, harassing a public servant, prohibited substance in a correctional facility and theft of a firearm. There were 3 cases each for engaging in organized criminal activity, unauthorized use of a motor vehicle, and evading arrest. There were 4 burglary cases and 4 cases of debit/credit card abuse.

Cases involving personal harm included 1 case for aggravated assault w/a deadly weapon, a case of continuous violence against family, stalking, deadly conduct and one case for sexual assault of a child under 14 continuously. There were 3 cases of assault on a family member.

Of the 53 cases, 12 were settled with Carol Crim receiving 4 years probation plus fines and costs for possession of a controlled substance PG1 less than a gram. For unauthorized use of a motor vehicle, Kimett Lane received a \$2000 fine. Anthony Lovingood received 15 months state jail for evading arrest w/ previous convictions. For possession of a controlled substance PG2 less than a gram Julia Banda of Saginaw, Texas received 4 years probation plus fines and costs. For harassment of a public servant, Adam Prado received 3 years probation plus fines and court costs.

Annelisa Hennigan received 3 years probation plus costs and fines for possession of a controlled substance PG1/ 1-4 grams.

Zachary Statler, on the charge of unauthorized use of a motor vehicle received 2 years TDCJ probated 5 years plus restitution and costs. Dustin Peak received 5 years TDCJ probated on each of two charges for DWI 3<sup>rd</sup> or more plus costs, fines and fees. Casey Estes of Lampasas, on two charges of possession of a controlled substance less than a gram, received 4 years probation plus costs and a fine and the stipulation of ISF on one charge, and saw one of his charges barred from prosecution. Chisum Brinkley saw his probation modified on a charge of manufacture and delivery of a controlled substance/PG1 4-200 grams.

The rest of the cases were reset or are awaiting trials.

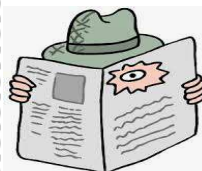

## Coronavirus Numbers

Statewide, on August 17<sup>th</sup>, there were 20,123 new and 4,299 probable cases, along with 12,227 in the hospital. There were 96 deaths from Covid reported as well. Locally, in the last 14 days, Lampasas has seen 151 confirmed cases according to the DSHS website, with 9 being confirmed yesterday. The state estimate is 201 active cases in Lampasas County.

## Special Election for Texas

Governor Greg Abbott has issued a proclamation setting Tuesday, November 2, 2021 as the special election day for eight proposed constitutional amendments in Texas.

The eight proposed amendments are

**PROPOSITION 1:** The constitutional amendment authorizing the professional sports team charitable foundations of organizations sanctioned by the Professional Rodeo Cowboys Association or the Women's Professional Rodeo Association to conduct charitable raffles at rodeo venues.

**PROPOSITION 2:** The constitutional amendment authorizing a county to finance the development or redevelopment of transportation or infrastructure in unproductive, underdeveloped, or blighted areas in the county.

**PROPOSITION 3:** The constitutional amendment to prohibit this state or a political subdivision of this state from prohibiting or limiting religious services of religious organizations.

**PROPOSITION 4:** The constitutional amendment changing the eligibility requirements for a justice of the supreme court, a judge of the court of criminal appeals, a justice of a court of appeals, and a district judge.

**PROPOSITION 5:** The constitutional amendment providing additional powers to the State Commission on Judicial Conduct with respect to candidates for judicial office.



**PROPOSITION 6:** The constitutional amendment establishing a right for residents of certain facilities to designate an essential caregiver for in-person visitation.

**PROPOSITION 7:** The constitutional amendment to allow the surviving spouse of a person who is disabled to receive a limitation on the school district ad valorem taxes on the spouse's residence homestead if the spouse is 55 years of age or older at the time of the person's death.

**PROPOSITION 8:** The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a member of the armed services of the United States who is killed or fatally injured in the line of duty.
