Unofficial Election Results

The election for the constitutional amendments is over, and here are the unofficial results:

Proposition 1: Allowing charitable raffles at rodeo events by the Professional Rodeo Cowboys Association or the Women's Professional Rodeo Association. 84% for 16% against.

Proposition 2: Authorizing counties to issue bonds or notes to raise funds for transportation and infrastructure in underdeveloped areas. 63% for 37% against

Proposition 3: Banning the state from prohibiting or limiting religious services, including those in churches and other places of worship. 63% for 37% against

Proposition 4: Requiring candidates to have 10 years of



experience practicing law in Texas to be eligible for election to the Texas Supreme Court, the Court of Criminal Appeals or a Texas court of appeals. 59% for 41% against.

Proposition 5: Allowing the State Commission on Judicial Conduct to have oversight of candidates running for judicial office by accepting complaints or reports, conducting investigations and reprimanding them. 59% for 41% against

Proposition 6: Allowing residents of nursing homes and assisted living facilities to designate one essential caregiver who cannot be denied in-person visitation rights. 88% for 12% against Proposition 7: Limiting school district property taxes incurred by the surviving spouse of a person with disabilities who is older than 65 and has died. 87% for 13% against

Proposition 8 Expanding eligibility for residential homestead property tax exemptions to include spouses of military members killed or fatally injured in the line of duty. 87% for 13% against.

Vaccines for Kids

Texas kids ages 5-11 will start getting their first COVID-19 vaccine injections this week after the U.S. Centers for Disease Control and Prevention late Tuesday approved the Pfizer-BioNTech vaccine for emergency use for that age group.



The move comes after nearly two years of sickness, grief, isolation and learning loss that accompanied the pandemic for the nation's young kids, including some 2.9 million Texas children ages 5-11.

The CDC director's announcement came hours after the agency's advisory panel recommended the shot for the nation's nearly 30 million children ages 5-12, clearing the final regulatory hurdle before the doses could be given to young kids.

Earlier Tuesday, the CDC's Advisory Committee on Immunization Practices voted unanimously to recommend it for the entire age group, without placing any limitations on who in that age group would qualify.

The CDC's was the final approval needed before younger children could be vaccinated. (Cont'd on back)

The Blotter

Coronavirus Update

Statewide, according to the DSHS, there were 922 new and 404 probable new cases on November 1st, along with 19 deaths. There were also 3,380 Texans in the hospital with Covid-19. Locally, the DSHS dashboard for cases shows 2 new confirmed cases in Lampasas County on November 1st, and 30 confirmed cases in the last 14 days. The state estimates Lampasas County to have 47 active cases at this time.

2313/190 Construction

LAMPASAS COUNTY – Texas Department of Transportation's (TxDOT) contractor, Texas Materials Group, Inc. of Cedar Park, will begin work on an intersection improvement project on US 190 at FM 2313 the week of November 1.

281 Construction

The Texas Department of Transportation (TxDOT) and the City of Lampasas propose an opportunity for comments on proposed improvements to US 281 between US 183 at US 190 (Ohnmeiss) and the Burnet County Line in Lampasas County, Texas.

Any environmental documentation or studies, maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT Brownwood District Office, 2495 HWY 183 N. Brownwood, Texas 76802, and 325-643-0442. Project materials are also available online at www.TxDOT.gov and search: US 281 from US 183 to Burnet County Line.

The proposed project would reconstruct the intersection of US 183 and Plum Street, reconfigure the intersection of US 281 (American Legion Memorial HWY) at US 190 (Ohnmeiss) and reconstruct the roadway to include continuous center turn-lane, curb and gutter, illumination, sidewalks, and drainage improvements between Sulphur Creek and the Burnet County Line along US 281 in Lampasas County, Texas.

All interested persons are invited to provide comments on the proposed project. Written comments from the public regarding this project are requested and may be submitted either in person or by mail to: Mr. Jason Scantling, P.E., Texas Department of Transportation, Brownwood District Office, 2495 Highway 183 North, Brownwood, Texas 76802. Written comments must be postmarked by Monday, Nov. 15, 2021 to be included in the notice and opportunity to comment summary

District Court Notes

Lampasas County Courthouse was the site of a 27th District Court Docket Call on October 29th. Presiding over the Court was 27th District Court Judge John Gauntt. Altogether 19 cases were brought to the court with 17 cases involving men, and 2 cases involving women. The following defendants failed to appear: Dakota Price of Lampasas on the charge of abandon/endanger a child/criminal negligence, Jeffrey Fielding of Gatesville on the charge of possession of a controlled substance PG1/less than a gram, and Shannon Crumbley of San Lorenzo, New Mexico on the charge of possession of a controlled substance PG1/4-200 grams.

There were 6 cases involving possession of a controlled substance/PG1. There were 3 cases for less than a gram, 2 cases for 1-4 grams, and 1 case for 4-200 grams. There was also 1 case for possession of a controlled substance/PG2 less than a gram, and one case for possession of a controlled substance PG1-1B (Fentanyl) 1-4 grams.

There were 4 burglary cases, two cases for theft \$2500-\$30,000, and one case each for evading w/ a vehicle/watercraft, tampering with evidence and robbery.

There was one case for aggravated sexual assault of a child, and one case for abandoning/endangering a child.

Of the 19 cases, 5 were settled with Joe Garza of Lampasas pleading guilty to tampering w/evidence and was sentenced to 8 years probation w/ SAFFP as a condition, and his other charge, possession of a controlled substance PG1/1-4 grams was barred. Kurt Avila of Kempner, on the charge of possession of a controlled substance PG1/less than a gram was sentenced to 90 days county jail with
